Conditions for the exercise of activities related to the organization and sale of travel or stays are governed by law no. 92-645 of July 13, 1992 (J.O. of 14.07.92) and its application decree no. 94-490 of June 15, 1994 (J.O. of 17.06.94) and apply to the proposed trip. Any registration implies acceptance of these general sales conditions.

1. REGISTRATIONS

To participate in the proposed trip, the registration request must be returned signed with a deposit of 40%, a second payment of 40% is requested by August 31, the balance must be paid before October 20. If the balance has not been paid by this date, the trip registration will be considered canceled and the client will have to pay the cancellation fees provided in paragraph 4 of these conditions.

2. PRICES

Our prices are from Paris CDG and arrival at Paris CDG. They include the services indicated in the paragraph services.

3. CANCELLATION / MODIFICATION BY THE ORGANIZER

TWINTOUR reserves the right to cancel the trip 45 days before departure due to an unforeseen event. As far as possible, a different departure date will be proposed to the participant. If the participant cannot accept the change, the amounts paid will be fully refunded. TWINTOUR reserves the right to modify the route or departure dates if this is imposed by unforeseeable events. In the event that weather conditions during the trip prevent the planned stages from being carried out or result in additional accommodation nights, the client agrees to cover this extra cost for the concerned duration.

4. CANCELLATION BY THE CLIENT

In accordance with article L.221-28-12 of the consumer code for tourist packages made outside the establishment, the right of withdrawal cannot be exercised. In case of cancellation, the client must inform TWINTOUR of their decision by mail. Depending on the date of cancellation, the client will have to pay the following cancellation fees: (postmark as proof)

More than 60 days before departure	20% of the total amount
From 59 to 40 days before departure	40% of the total amount
From 39 to 20 days before departure	60% of the total amount
From 19 to 10 days before departure	80% of the total amount
Less than 10 days before departure	100% of the total amount

5. TRANSFER OF A CONTRACT

The participant may transfer their contract no later than 10 days before the start of the trip to a person who meets all the conditions required to make the trip and who has signed these conditions, provided the airline tickets are changeable. This replacement by another participant will incur a flat-rate billing of €90 plus the tariff adjustments of the services on the day of the modification. The transferor and the transferee will be jointly responsible for the payment of the balance of the price.

6. LIMITS OF LIABILITY

TWINTOUR is not responsible for:

Maritime and air transport: a maritime or airline company may change the date or time of departure, especially during a strike by the company's staff or ports and airports, or due to overbooking, or because of a ferry/plane breakdown, or for the traveler's safety, or for any delay/cancellation due to weather conditions (storms at sea, bad weather, volcanic eruption, cyclones, etc.). In such cases, TWINTOUR's liability cannot be engaged, and no compensation can be claimed, even if the initial program is modified or arrival is delayed.

Failures, illegal acts, or faults of hoteliers and other service providers, as well as their employees and agents, causing harm to participants, their belongings, and personal effects.

In case of interruption or cancellation of the trip caused by force majeure incidents (war, revolt, catastrophe, epidemic, storms, fuel shortages, etc.), TWINTOUR will not cover the costs and expenses incurred by these incidents.

In case of conflicts or disturbances arising in the countries traversed, TWINTOUR will not be responsible for the inability to honor all or part of the services.

TWINTOUR's liability cannot be engaged if the quality of accommodation during the trip is deemed insufficient by the client.

TWINTOUR is not responsible for losses, theft, bodily harm, or material damage that may occur during the trip, and the participant agrees to waive any civil or criminal action against TWINTOUR.

Under no circumstances can TWINTOUR be held responsible in the event of traffic accidents or incidents due to external factors (weather incidents, poor road conditions, stray animals, natural disasters).

TWINTOUR will not be responsible for the non-payment of participants' extras, damages, or degradations they may cause during the trip, and fines for which participants are responsible; all these costs are the exclusive responsibility of the participant.

7. PARTICIPANT'S OBLIGATIONS

The participant is fully responsible for themselves and their accompanying close ones' safety.

The participant must comply with the rules and laws in force in the countries visited. In case of violation, they will be solely responsible, particularly if they omit wearing a helmet (for motorcyclists) or in case of use, possession, or transportation of narcotics, as well as in case of exceeding the legal blood alcohol limit. They commit to respecting speed limits and safety rules in force in the country.

They must be accustomed to driving and able to drive for an extended period.

The participant agrees to return their vehicle to their home, releasing Twintour from any responsibility. The participant presents themselves with a car in perfect working order, especially concerning tires and brakes. *In case of breakdown or accident, they will have to manage their vehicle and collateral problems themselves, with their own insurance, as Twintour does not provide mechanical assistance, and the group cannot suffer from a car breakdown.*

8. INSURANCE

Twintour offers participants who register more than 30 days before departure and whose trip cost is less than €8,000 per person, to subscribe to the Axa group insurance contract to cover the risk of trip cancellation until the day of departure. The possible repatriation of the vehicle must be done by the participant's vehicle insurer. The following guarantees will be available to people whose usual residence is in mainland France or bordering European countries and Switzerland, for a contribution of 4% of the trip amount. A summary of the guarantees is indicated below, the general provisions of the contract will be sent to you at the same time as your travel booklet:

Cancellation: reimbursement of amounts due according to the trip's sales conditions described above (excluding administrative fees and insurance premium) when you are obliged to cancel your trip before departure, in case of:

- o serious illness, serious accident, or death of yourself, your legal or de facto spouse, or the person accompanying you, provided they appear on the same invoice (including the worsening of previous illnesses and the consequences of a previous accident)
- o your ascendants or descendants and/or those of your spouse or those of the person accompanying you, provided they appear on the same invoice
- o your brothers, sisters, brothers-in-law, sisters-in-law, sons-in-law, daughters-in-law
- o economic dismissal of yourself or your spouse
- o in case of clear and unforeseeable complication of your pregnancy, miscarriage, therapeutic termination of pregnancy and their consequences
- o in case of a pregnancy not known at the time of registration for the trip and contraindicating the trip due to its very nature
- o in case of your administrative summons, imperatively attested by an official document, unforeseeable and non-deferrable, for a date falling during your trip, provided the summons was not known on the date of subscription of this agreement
- o the destruction of professional and/or private premises by more than 50% due to fire, explosion, or water damage.

- Any claim must be reported within two days to the Twintour company (by fax, email, or mail, with the postmark as proof) and then confirmed by registered letter with acknowledgment of receipt to the Twintour company within five days (two days for baggage) and to Axa assistance for the implementation of the guarantees. The date of occurrence of the claim will, in all cases, determine the amount of insurance compensation.

What is not covered by Axa insurance:

- Common exclusions to all risks: civil or foreign war, riots, popular movements, voluntary participation of an insured person in riots or strikes, pandemics and viral epidemics of all kinds, disintegration of the atomic nucleus or any irradiation from a radioactive energy source, alcoholism, intoxication, use of drugs or narcotics not medically prescribed, any intentional act that may trigger the contract's guarantee.
- Cancellation caused by a person hospitalized at the time of booking the trip or subscribing to the contract.
- Pregnancy complications.
- Illness requiring psychiatric or psychotherapeutic treatments, including nervous breakdowns, not requiring hospitalization for a minimum of 5 days at the time of trip cancellation.
- Contraindication or forgetting of vaccination.
- Accidents resulting from the practice of the following sports: bobsleigh, climbing, skeleton, mountaineering, competitive luge, all aerial sports, as well as those resulting from participation or training in matches or competitions.
- Failure to present, for any reason, essential travel documents, such as passport, visa, travel tickets, vaccination certificate.
- Illnesses, accidents first diagnosed, relapsed, worsened, or hospitalized between the date of purchase of your trip and the date of subscription of this contract.
- Mechanical breakdowns occurring to your vehicle.

9. COMPLAINT

Any complaint must be made by registered mail no later than 15 days after returning from the trip, accompanied by the incident report issued by the local service provider. It is specified that any complaint made by fax, phone, simple mail, email, or other means, made outside the deadline, or not made to the relevant service providers if applicable, will not be taken into account. In case of a dispute, the applicant can refer to either one of the territorially competent courts under the civil procedure code or the court of the place where they resided at the time of the contract conclusion. After this period, no complaint will be considered. We will try our best to resolve any disputes amicably. TWINTOUR has subscribed to a professional liability insurance contract with GENERALI France in Paris and benefits from a financial guarantee with APST.

10. ADMINISTRATIVE FORMALITIES

During the trip, the participant must have the following documents:

- A valid driving license
- A valid identity card for European countries and Croatia, a valid passport for non-European countries.
- The vehicle's registration certificate, and if not the owner, a signed authorization from the owner.
- Insurance certificate (green card) indicating that the visited country is indeed covered by their insurance company (especially for Morocco, Tunisia, Turkey)
- If the participant does not pay for the entire trip with a high-end bank card that covers medical repatriation, they must ensure that their insurance covers medical repatriation.
