Winding roads in Corsica with magnificent scenery, very rolling stages, mountain and seaside roads, 4 & 5 star hotels close to the beach, visits and tastings of local produce - that's the program for this Premium Rally in the Mediterranean!

Stages :

Friday September 13, Marseille / Bastia ferry.

Embarkation in the evening at around 6:00 p.m. in the port of Marseille, bound for Bastia. Dinner on board, briefing, then overnight in your individual cabin with private bathroom. Suite cabin option available at extra charge, subject to availability.

Saturday September 14, Bastia/ Calvi, 240 kms, approx. 5h30 driving time.

Arriving in Bastia at around 8.00 am, we set off for Cap Corse, an unforgettable adventure, between picturesque villages perched on green hills, secluded beaches with crystal-clear waters, and delicious seafood dishes, all enveloped in the air imbued with Corsican history and culture. We'll also pass through some of Corsica's most emblematic towns, including Centuri, Saint Florent and Ile Rousse, before reaching Calvi. Calvi, with its sandy beaches, bustling port, medieval old town and majestic view of the citadel, embodies the essence of Corsican beauty. We'll spend the night at the 5-star Le Corsica hotel and spa.

Sunday September 15, Calvi / Propriano, 255 kms, approx. 5h30 of driving.

For this second day on the road, we're heading for the south of Corsica. We'll pass through the Calanques de Piana, a UNESCO World Heritage site, transporting you into a world of striking contrasts, where wild nature mingles with the turquoise sea, offering breathtaking panoramas. We'll then pass through small mountain villages before arriving at the Sant'Armettu winery, which we'll have a chance to visit before arriving at the Hotel Bartaccia, less than 500 meters from the beach and close to the town center of the charming seaside resort of Propriano.

Monday September 16, Propriano / Sainte Lucie De Porto Vecchio, 225 kms, approx. 4h40 driving time.

We take the mountain roads to Bonifacio, passing through the heights of Roccapina. Bonifacio, perched on white cliffs overlooking the Mediterranean Sea, is a medieval corsair town of exceptional beauty, where history, culture and spectacular panoramas meet. We then head for Sainte Lucie de Porto Vecchio, passing the impressive Aiguilles de Bavella. These rocky peaks in the Corsican mountains offer a breathtaking natural spectacle, with their sharp ridges and panoramic views over alpine landscapes and pine forests. We'll spend two nights at the 5-star Les Régalia hotel and spa. Soirée blanche elegance and style: dress in white for a night to remember! Three suite options available at extra cost: Violette, Suzanne and Antoinette.

Tuesday September 17, Day off.

Sainte Lucie de Porto-Vecchio is close to some of Corsica's most beautiful beaches, including Palombaggia Beach, renowned for its crystal-clear waters and fine sand. Nature lovers can explore the Ospedale nature reserve, a picturesque mountain region offering hiking trails, waterfalls and panoramic views of the coast. Porto-Vecchio itself offers authentic Mediterranean charm with its restaurants, stores, bustling port and old town, perfect for a picturesque stroll on this free day out.

Wednesday, September 18, Porto Vecchio / Saint Florent, 285 kms, approx. 5h40 driving time

We head for Ghisoni, mountain roads, Corte and then Bravone, where we'll meet a local producer who'll offer us a Corsican cheese activity before lunch in idyllic surroundings. Then it's back on to the seaside resort of Saint Florent. This port town in north-west Corsica is renowned for its magnificent beaches, port and relaxed Mediterranean atmosphere. We'll be staying at La Roya, a 4-star hotel with refined charm located in Cap Corse, in the heart of the Gulf of Saint Florent by the sea. With our feet in the water and our eyes looking out over the village, we'll enjoy this Garden of Eden for our last night in Corsica, with 4 sea-view suite options available at extra cost, subject to availability.

Thursday September 19, Saint Florent / Ile Rousse, 130 kms, 3h driving time

We leave Saint Florent for Ile Rousse via mountain roads. Surprise activity in Ile Rousse before boarding the Corsica Linea ferry to Marseille in the late afternoon. Cabin suite option available at extra cost, subject to availability.

The conditions of practice for activities relating to the organization and sale of trips or stays are governed by law n° 92-645 of July 13, 1992 (J.O. of 14.07.92) and its application decree n° 94-490 of June 15, 1994 (J.O. of 17.06.94) and apply to the proposed trip. All registrations imply acceptance of these general terms and conditions of sale.

1. REGISTRATION

To participate in the proposed trip, the registration form must be returned signed with a deposit of 40%, with the balance due 45 days before departure. If the balance has not been paid by this date, registration for the trip will be considered cancelled and the customer will be liable for the cancellation charges stipulated in paragraph 4 of these conditions.

2. RATES

Our rates are based on departure from Marseille and arrival in Marseille. They include the services indicated in the services paragraph.

3. CANCELLATION / MODIFICATION BY THE ORGANIZER

TWINTOUR reserves the right to cancel a trip 45 days prior to departure due to unforeseen circumstances. If possible, a different departure date will be proposed to the participant. If the participant cannot accept the change, the amounts paid will be refunded in full. TWINTOUR reserves the right to modify the tour or departure dates if forced to do so by unforeseeable events. In the event that climatic conditions during the trip prevent the completion of the stages scheduled in the program or result in additional nights' accommodation, the customer undertakes to cover this additional cost for the duration concerned.

4. CANCELLATION BY THE CUSTOMER

In accordance with article L.221-28-12 of the French Consumer Code, the right of withdrawal cannot be exercised in the case of off-premises tourist packages. In the event of cancellation, the customer must inform TWINTOUR of his decision by post. Depending on the date of cancellation, the customer must pay the following cancellation fees: (as per postmark)

- More than 60 days before departure 20% of the total amount
- 59 to 40 days before departure40% of total amount
- 39 to 20 days before departure60% of total amount
- 19 to 10 days before departure80% of total amount
- Less than 10 days before departure100% of total amount

5. TRANSFER OF CONTRACT

The participant may assign his or her contract no later than 10 days before the start of the trip to a person who meets all the conditions required to take part in the trip and who has signed the present conditions, provided that the ferry or air tickets can be changed. This replacement by another participant will result in a flat-rate charge of €90 for expenses, to which will be added the price adjustments for services on the day of the modification. The transferor and the transferee will be jointly and severally liable for payment of the balance of the price.

6. LIMITS OF LIABILITY

TWINTOUR is not liable for :

Sea and air transport: a sea or air company may have to change the date or time of departure, particularly in the event of a strike by the company's personnel or by ports and airports, or due to overbooking, or because of a ferry/plane breakdown, or for reasons of passenger safety, or for any delay/cancellation due to atmospheric conditions (storms at sea, bad weather, volcanic eruption, cyclones...). In such cases, TWINTOUR cannot be held responsible, and no compensation can be claimed, even in the event of a change to the program initially planned or a delayed arrival.

Breaches, illegal acts or misconduct by hoteliers and other service providers, as well as their employees and agents, which are detrimental to the participants, their belongings and personal effects.

In the event of interruption or cancellation of the trip caused by incidents of force majeure (war, uprising, disaster, epidemic, storm, fuel shortage, etc.) TWINTOUR will not assume the costs and disbursements caused by these incidents. In the event of conflict or unrest in the countries visited, TWINTOUR will not be held responsible for the impossibility of providing all or part of the services. Twintour cannot be held responsible if the quality of the accommodation is deemed insufficient by the customer. TWINTOUR is not responsible for any loss, theft, personal injury or material damage that may occur during the trip, and the participant agrees to waive any civil or criminal recourse against TWINTOUR. TWINTOUR cannot be held responsible for traffic accidents or incidents due to external factors (climatic incidents, poor road conditions, stray animals, natural disasters).

TWINTOUR will not be held responsible for non-payment of extras by participants, for any damage or deterioration they may cause during the trip, or for any fines for which participants may be responsible, all of which are the exclusive responsibility of the participant.

7. OBLIGATIONS OF THE PARTICIPANT

The participant is fully responsible for his or her own safety and that of any family members accompanying him or her. The participant must respect the rules and laws in force in the countries visited. In the event of transgression, he/she alone will be liable, in particular if he/she fails to wear a helmet (for motorcyclists) or in the event of use, possession or transport of narcotics, as well as in the event of exceeding the legal blood alcohol level. He/she undertakes to respect the speed limits and safety rules in force in the country.

He/she must be accustomed to driving and be able to drive for an extended period.

The participant undertakes to return his or her vehicle to his or her place of residence, Twintour being released from all liability. The participant must present a car in perfect working order, especially as regards tires and brakes. In the event of a breakdown or accident, the participant is responsible for managing his or her own vehicle and any collateral problems, using his or her own insurance. Twintour does not provide mechanical assistance, and the group cannot be held liable for the breakdown of a car.

Twintour reserves the right to exclude a participant without compensation or reimbursement in the event of risk-taking deemed dangerous by the organization, or a lack of respect towards another participant, service providers or the organization.

8. INSURANCE

Twintour suggests that participants who register more than 30 days before departure, subscribe to the Axa group insurance policy to cover the risks of cancellation of the trip up to the day of departure. Any repatriation of the vehicle must be carried out by the insurer of the participant's vehicle. The following cover is available to people whose habitual place of residence is in mainland France or in European border countries and Switzerland, in return for a contribution of 4% of the cost of the trip. Cancellation: reimbursement of sums due according to the conditions of sale of the trip described above (excluding booking fees and insurance premium) when you are obliged to cancel your trip before departure, in the event of :

- serious illness, serious accident or death of yourself, your legal or de facto spouse or the person accompanying you, provided they appear on the same invoice (including aggravation of previous illnesses and after-effects of a previous accident)
- your ascendants or descendants and/or those of your spouse or those of the person accompanying you, provided that they appear on the same invoice
- your brothers, sisters, brothers-in-law, sisters-in-law, sons-in-law, daughters-in-law.
- economic redundancy of yourself or your spouse
- in the event of a clear and unforeseeable complication of your pregnancy, miscarriage, therapeutic termination of pregnancy and their consequences;
- in the event of a pregnancy unknown at the time of booking and which, by its very nature, contraindicates the trip;
- in the event of your being summoned by an official document, which is unforeseeable and cannot be postponed to a date during your Trip, provided that the summons was not known at the time the present agreement was taken out;
- destruction of more than 50% of your business and/or private premises by fire, explosion or water damage.
- All claims must be reported to Twintour within two days (by fax, e-mail or postmarked), then confirmed by registered letter with acknowledgement of receipt to Twintour within five days (2 days for luggage) and to Axa assistance in order to activate cover. In all cases, the date on which the claim occurs will determine the amount of insurance compensation.

What is not covered by Axa insurance :

- Exclusions common to all risks: civil or foreign war, riots, civil commotion, voluntary participation by an insured person in riots or strikes, pandemics and viral epidemics of all kinds, disintegration of the atomic nucleus or any irradiation from a radioactive energy source, alcoholism, drunkenness, use of medication, drugs or narcotics not prescribed by a doctor, any intentional act that may result in the contract being covered.
- Cancellation caused by a person hospitalized at the time the trip is booked or the contract is taken out.
- Complications of pregnancy.
- Illness requiring psychological or psychotherapeutic treatment, including nervous breakdowns, which have not required hospitalization of at least 5 days at the time of cancellation of the trip.
- Vaccination contraindications or omissions.
- Accidents resulting from the practice of the following sports: bobsleigh, rock-climbing, Skelton, mountaineering, competitive luge, all aerial sports, as well as those resulting from participation in or training for matches or competitions.
- Non-presentation, for any reason whatsoever, of documents essential to the trip, such as passports, visas, travel tickets and vaccination certificates.
- Illnesses or accidents first diagnosed, relapsed, aggravated or hospitalized between the date of purchase of your trip and the date of purchase of this contract.
- Mechanical breakdown of your vehicle.

9. COMPLAINTS

All claims must be made by registered mail no later than 15 days after your return from the trip, and must be accompanied by the incident report issued by the local service provider. Please note that any complaint made by fax, telephone, ordinary mail, e-mail or any other means, or made after the deadline, or not made to the service provider(s) concerned, will not be taken into account. In the event of a dispute, the claimant may bring the matter either before one of the courts having territorial jurisdiction under the French Code of Civil Procedure, or before the court for the place where the claimant resided at the time the contract was concluded. After this period, no claim will be taken into consideration. We will do our utmost to settle any disputes amicably. TWINTOUR has taken out a professional liability insurance policy with GENERALI France in Paris and benefits from a financial guarantee with APST.

10. ADMINISTRATIVE FORMALITIES

During the trip, the participant must be in possession of the following documents:

- A valid driving license
 - Valid identity card for European countries and Croatia, a valid passport.
 - Vehicle registration document, and if you don't own the vehicle, a signed authorization from the owner.
- Insurance certificate (green card) showing that the country visited is covered by the insurance company (particularly for Morocco, Tunisia and Turkey).
- If the participant does not pay for the entire trip with a "top-of-the-range" bank card that covers medical repatriation, he/she must ensure that his/her insurance covers medical repatriation.

11. MISCELLANEOUS :

Stages may be modified for imperative reasons or if one of the service providers cancels or modifies the planned services. With regard to image rights, registration for the rally implies acceptance of the use of images of drivers, co-drivers and vehicles, which may be exploited and used directly by the organization in all forms and media, for an unlimited territory, with no time limit, in full or in excerpts, and in particular in the press, books, digital media, exhibitions, advertising, public screenings, competitions, websites and social networks. It also implies acceptance of the use of images broadcast by participants during the rally.
